I am writing to urge your organization to co-sponsor our **47th Annual Conference and Multifaith Service for Peace on Sunday, November 15 in Princeton, NJ.**

The event begins with an **11:00 AM Multifaith Service at Princeton University Chapel** which is free and open to the public. There will be an option to watch via livestream. Faith leaders from a wide range of backgrounds will co-lead the Service, which will include a free will offering to benefit CFPA.

Preaching will be **the Rev. Dr. Karen Georgia Thompson**, former General Minister, Chief Executive Officer, and President of the United Church of Christ.

Rev. Dr. Thompson will also speak at the afternoon **Conference for Peace** which will be from **1:30-4:30 PM at Nassau Presbyterian Church**, located at 61 Nassau Street in **Princeton**. In addition, other confirmed speakers include:

Dr. Laura Grego, Senior Research Director of the Global Security Program at the Union of Concerned Scientists, where she has worked at the intersection of science and public policy, in particular nuclear weapons, missile defense, and space security issues, for twenty years.

Rep. Bonnie Watson Coleman will be retiring after serving six terms in the United States House of Representatives, the continuation of a career in public service advocating for the needs of New Jersey families and the equitable treatment of all people. She is the first Black woman to represent New Jersey in Congress. There will be a special Reception at the end of the Conference to honor Watson Coleman for her stalwart advocacy for peace and justice.

Benjamin Dziobek is the founder of Climate Revolution Action Network (CRAN), New Jersey's largest Gen Z political advocacy group. The group mobilizes citizens to testify before the state government, and lobbies for legislation that would require fossil fuel companies to help cover the costs of climate-related damage in New Jersey.
